

1. POSITION PURPOSE

- The Vascular Registrar is responsible, in conjunction with the Vascular Surgeons for the continuing care of all Vascular patients within their unit.
- The Vascular Registrar is responsible for ensuring that patients are reviewed daily and that regular medical progress notes are documented in the medical record.
- The Vascular Registrar will attend all formal rounds, outpatient and theatre sessions as rostered and as directed from time to time by the Surgeons of the Unit.
- The Vascular Registrar is responsible for appropriate communication with patient, family and other staff involved in patient care. Where possible, within rostered hours, attend surgical ward meetings.
- The Registrar is responsible for supporting and supervising the work of the units HMOs including ensuring and if necessary assisting in the production of timely and accurate discharge summaries.
- The Registrar is to be contactable when on duty or on call by agreed upon methods of communication.
- The Registrar will ensure that all errors or incidents are reported using the Victorian Health Incident Management System and will complete as part of any audit the organisational Mortality and Morbidity reporting tool

2. MAJOR DUTIES AND/OR RESPONSIBILITIES

- Develop skills in assessing and managing vascular patients presenting to the Emergency Department.
- Develop skills in assessing and managing vascular inpatients via ward rounds and resident supervision on the wards.
- Develop skills in assessing and managing vascular patients in the outpatient clinic.
- Develop operating skills in a supervised environment of both elective and critical vascular patients.
- Develop skills in organising and coordinating patients' waiting list arrangements for elective operations and theatre list bookings.
- Attend Outpatient clinics at Box Hill Hospital..
- Develop improved vascular knowledge via self-directed education.
- Participate and co-ordinate educational tutorials for the HMO's.
- Participate in the after hours On Call roster.
- Develop skills in performing audits of the vascular departments' operative and non-operative patients.
- Develop skills in organising and conducting multi-disciplinary meetings and clinical case conferences.
- Develop knowledge and organize vascular equipment for surgery.
- Conduct telephone enquires from referring GP's.
- Co-ordinate research activities both within and between the vascular unit and other units
- Liaise with other units to facilitate combined cases

3. SAFE PRACTICE AND ENVIRONMENT

Occupational Health and Safety

Any information obtained in the course of employment is confidential and should not be used for any purpose other than the performance of the duties for which the person was employed. Staff are bound by the Information Privacy Act 2000 and the Health Records Act 2001.

A Performance Review, that includes agreed targets, will occur three (3) months from commencement and then annually on the basis of the duties and responsibilities outlined in this position description. This is an opportunity to review personal and the allocated work unit's service performance, facilitated by the setting of objectives/goals and ongoing evaluation of performance and achievement. Objectives will be developed annually, documented, discussed and agreed with the immediate line manager, who will act as the assessor. The incumbent is expected to demonstrate and show evidence annually of on-going self and allocated work unit's service development.

- Must hold a MBBS or equivalent degree and be generally registered as a Medical Practitioner with the Australian Health Practitioner Regulation Agency (AHPRA)
- A minimum of three years experience within the Australian Hospital system.
- A demonstrated interest in Vascular Surgery
- Vascular Surgery at Eastern Health is provided at Box Hill Hospital. Patients presenting to Angliss Hospital and Maroondah Hospital who require vascular surgery are referred to Box Hill Hospital. An outpatient clinic operates from Box Hill Hospital, seeing approximately 2100 patients per annum.

- Appropriate management of patients in accordance with Hospital policies and protocols.
