1. POSITION PURPOSE

The Clinical Psychologist is a key member of the Mental Health Program Rehabilitation Stream working within the Mobile Support Team (MST). The position will ensure that a range of high-quality specialist psychology interventions are provided to assist people within MSTS to achieve their recovery goals, leading an improved quality of life. This position is responsible for promoting the principles and practice of service coordination to ensure that consumers are at the centre of service delivery and receive a timely, coordinated response to their health and social needs.

2. MAJOR DUTIES AND/OR RESPONSIBILITIES

- To provide high quality clinical services working in partnership with consumers and carers.
- Provide comprehensive clinical psychology and mental health assessment, treatment, risk assessment and consultation services with relevant others that promotes and facilitates recovery.
- Provide specialist psychology knowledge and skills to the multidisciplinary team and give advice to staff on specialist psychology outcomes and strategies including psychology specific assessments.
- Initiate, plan, implement and evaluate psychology services in consultation with consumers, carers and the multi-disciplinary team both at the clinic and in the consumers own environment as need be.
- Review consumer behaviour support plans, providing suggestions for behaviour management strategies, and attending care team meetings to support the implementation of behaviour management/education to the broader care team.
- Contribute to service wide response plans for consumers within the MSTS.
- To contribute to 'best practice' multidisciplinary teamwork that is evidence based.
- Actively promote and participate in the delivery of the Collaborative Recovery Model.
- Possess knowledge of and the ability to provide effective interventions for consumers with cooccurring mental health and substance use problems (dual diagnosis) as a core component of the clinical role
- Promote the principles and practice of service coordination to ensure that consumers are at the centre of service delivery and receive a timely, coordinated response to their health and social needs.
- Demonstration of relevant family violence practice according to allocated responsibility level in the
 mental health program workforce mapping tool. This aligns with the Multi-Agency Risk assessment
 and Management (MARAM) Framework, the Family Violence Information Sharing Scheme (FVIS) and
 Child Information Sharing Scheme (CISS) legislative requirements and related Eastern Health
 guidelines.
- Develop knowledge of local resources and services to make appropriate referrals; provide advocacy; and initiate service development activities that will proactively enhance consumer access to community services.
- Participate in handover and clinical review meetings that guide implementation and evaluation of consumer treatment objectives provided by the multidisciplinary team.
- Comply with data collection and reporting requirements along with administrative procedures as required including use of Outcome Measurement tools.
- Adhere to and comply with relevant legislation i.e. Mental Health and Wellbeing Act 2022.
- At all times works within the professional standards, codes and behaviours that are legislated through the relevant professional bodies and Eastern Health Policy, Standards and Practice Guidelines.

- Practice in accordance with the recovery principles as outlined in the 'Framework for recovery-oriented practice" (Department of Health 2011).
- Engage in clinical supervision, line supervision and professional supervision as required by Eastern Health and AHPRA standards. Committed to provide supervision to junior psychologists and psychology students.
- Demonstrated commitment to ongoing professional development including all mandatory training requirements.
- Participate in and meet the standards of the EH Allied Health Credentialing and Professional Standards.
- Participate in the implementation of the operational improvement plans and plan an active role in accreditation activities.
- Contribute to sustaining a positive team environment that maximises the range of consumer services available through the multidisciplinary team.
- A sound working knowledge of and commitment to working with consumer from a wide range of ethnic and social backgrounds and providing services that are family and gender sensitive
- To ensure that Eastern Health's objectives are upheld and that the standards, practice guidelines and legal requirements are adhered to and/or implemented.
- Other duties as directed by the Manager AMHS Rehabilitation Services/ MSTS Team Leader (or their delegates), for the efficient and effective running of the service.

The incumbent is expected to demonstrate and show evidence annually of on-going self and allocated work unit's service development.

SPECIALTY SPECIFIC INFORMATION: Organizational Context

Eastern Health provides a broad range of acute, sub-acute, aged and mental health services to approximately 800,000 people in the eastern suburbs of Melbourne. Eastern Health has approximately 8,500 staff and covers a geographical area of 2800 sq kms. Eastern Health is affiliated as a teaching health service with Deakin, Latrobe and Monash Universities.

Eastern Health's Mental Health Program provides Tier 3 mental health care for all ages in the Eastern Metropolitan Region of Melbourne. Fundamental to our service delivery are the principles of recovery oriented mental health practice.

Our services cover the continuum of care and include both inpatient and outreach services in the following divisions:

- Child and Youth Mental Health Services (CYMHS)
- Adult Mental Health Services (AMHS)
- Aged Person Mental Health Program (APMH)
- Research and academic programs

The Mental Health & Wellbeing Program works in partnership with State-wide Services which include the following divisions:

- Alcohol and Drug Service
- SPECTRUM (statewide service for people with a personality disorder)
- Dual Diagnosis

Mobile Support and Treatment Service (MSTS) offers community recovery orientated services, consultation, assessment and treatment and support to people with a mental illness, and their carers and families, between the ages of 16 and 64.MSTS staff focus on working collaboratively with consumers with a lived experience of mental ill health and their support networks to help them pursue a life based on their own strengths, values and recovery goals

 Assertive outreach and intensive support, utilizing recovery-focused goal setting to promote hope, enhance consumers' community access, and foster the development of independent living skills.

Box Hill Mobile Support & Treatment Service (BHMSTS) is located in the Central East Catchment and supports those who live in the Municipalities of Whitehorse (west of Springvale Road), Manningham and Monash. It is colocated with some Central East Teams.

Maroondah Mobile Support Team (MMSTS) is located in the Outer East Catchment and supports those who live in the Municipalities of Knox, Yarra Ranges, Maroondah and Whitehorse (east of Springvale Road). It is colocated with some of the Outer East Teams.
