1. POSITION PURPOSE

This position is an Eastern Health position and is responsible for delivering an antimicrobial stewardship program across the Eastern Health network as delegated by the Lead Antimicrobial Stewardship pharmacist. This position is part of an antimicrobial stewardship (AMS) pharmacy team and will work closely with the lead pharmacist, infectious disease physicians and antimicrobial stewardship technician.

This position will require travel to the multiple Eastern Health sites.

2. MAJOR DUTIES AND/OR RESPONSIBILITIES

Support and contribute to the activities of the Antimicrobial Stewardship Program as delegated by the Lead Antimicrobial Stewardship Pharmacist

- Assists with activities to ensure Eastern Health complies and delivers care consistent with the national standards for Antimicrobial Stewardship (standard 3)
- Assists with the activities of the Antimicrobial Stewardship Program
- A member of the Antimicrobial Stewardship Committee
- A close liaison with the Infectious Diseases Department
- Maintain the Eastern Health Antimicrobial Guidelines website
- Regularly review and update antimicrobial guidelines for Eastern Health
- Promote the ongoing activities of antimicrobial stewardship to consumers, pharmacy staff, nurses and medical staff.
- Monitor and manage antimicrobial use and expenditure within Eastern Health
- Attend Infectious Diseases Consultant rounds
- Conduct Antimicrobial Stewardship Rounds
- Set up and maintain an audit schedule for the antimicrobial stewardship program that align with quality indicators and clinical care standards
 - Conduct regular audits involving antimicrobial use in different settings
- Review and contribute to actions relating to antimicrobial stewardship on the Innovation and Improvement Plan
- Provide advice and implement strategies to improve the cost-effective and quality use of antimicrobials
- Education of medical, nursing and pharmacy staff with regards to antimicrobials
- Oversee the documentation of ongoing activities for evidence of a cost effective service
- Participate in ongoing research relating to infectious diseases or antimicrobial stewardship
- Provide support for the infectious diseases team including provision of advice and drug information
- Development and contribution to practice based research program relevant to the pharmacy, Directorate or Service
- Facilitate and participate in the delivery of continuing education and structured education programs to pharmacy staff (including those undertaking undergraduate and postgraduate education)
- Provide support and education to team members, mentor and oversee inexperienced team members, and assist the APD to drive a culture of professional development within pharmacy staff rostered to relevant clinical services areas.
- Able to work in a non-discriminatory and harassment free environment
- Manage clinical services orientation and training requirements specified by Lead AMS pharmacist

- Develop and participate in project, research (in consultation with EH Pharmacy Practice Research Group) and quality improvement activities in relevant portfolio area as delegated by Lead AMS pharmacist
- Contribute to the presentation and/or publication of service improvement projects at relevant professional forums in relevant portfolio area

In addition, you must ensure that you practice within the specifications of this position description, and where applicable within the agreed scope of practice.

You are responsible for ensuring safe high quality care in your work. This will include complying with best practice standards, identifying and reporting any variance to expected standards and minimising the risk of adverse outcomes and patient harm. In addition, you will ensure that service and care is consistent with the EH approach to patient and family centered care.

6. CONFIDENTIALITY

Any information obtained in the course of employment is confidential and should not be used for any purpose other than the performance of the duties for which the person was employed. Staff are bound by the Information Privacy Act 2000 and the Health Records Act 2001.

7. EQUAL EMPLOYMENT OPPORTUNITY

You agree to adhere to the Equal Employment Opportunity policies and practices of the Health Service. Discriminatory practices, including sexual harassment, are unlawful. A Performance Review, that includes agreed targets, will occur three (3) months from commencement and then annually on the basis of the duties and responsibilities outlined in this position description. This is an opportunity to review personal and the allocated work unit's service performance, facilitated by the setting of objectives/goals and ongoing evaluation of performance and achievement. Objectives will be developed annually, documented, discussed and agreed with the immediate line manager, who will act as the assessor. The incumbent is expected to demonstrate and show evidence annually of on-going self and allocated work unit's service development.

Essential:

- Registered or eligible for registration as a Pharmacist with the Australian Health Practitioner Regulation Agency (AHPRA)
- Current and advanced hospital pharmacy experience, including effective clinical pharmacy skills
- Sound knowledge and understanding of all relevant aspects of hospital pharmacy. In particular, demonstrated ability to practice in accordance with Society of Hospital Pharmacists of Australia (SHPA) Guidelines
- Demonstrate commitment to optimum patient focused care and professional practice
- Developed staff supervision, interpersonal skills, ability to facilitate open discussion and resolve conflict.
- Demonstrated ability to perform under pressure, to meet time constraints and determine work priorities and a high level of organisational skills
- Demonstrated competence in drug knowledge, especially antimicrobial therapy and its application in the clinical setting
