1. POSITION PURPOSE

The Eastern Health Transition to Practice (Graduate) Clinical Nurse Educator is responsible for the delivery of the Transition to Practice program requirements across all Eastern Health sites.

The incumbent will liaise with key stakeholders within operational teams under the Learning and Teaching leadership team to ensure all governance and clinical requirements of program are met in accordance with the terms of the Department of Health Transition to Practice Program guidelines, operational requirements and feedback and evaluation from learners. Key stakeholders of the program include operational teams, Learning and Teaching staff (all professions), Education Providers as well as current and prospective Transition to Practice learners.

The program delivery encompasses, marketing, bulk intake recruitment, supporting learner health, wellbeing and performance, liaising with graduate representative group, planning, delivery and evaluation of formal profession specific and interprofessional study day programs, monitoring of program requirements and planning rotations of learners across the health service.

2. MAJOR DUTIES AND/OR RESPONSIBILITIES

2.1 Clinical and Professional Leadership

Provides strong and effective leadership in the area of Clinical Education Indicators:

- Maintains governance of the programs in line with the Department of Health and Human Services requirements and recommendations
- Supports the development and implementation of policies, procedures, strategies and projects
- Participates and contributes to the Transition to Practice Program team meetings and initiatives
- Promotes the development, identification and implementation of evidence based practice
- Promotes participation in research and quality improvement activities
- Demonstrates leadership in staff meetings via identification of relevant issues
- Displays strong leadership of individual profession as part of working parties, committees and internal / external forums
- Acts as a role model for staff within the Eastern Health
- Assists in raising the profile of novice learner programs by representing Eastern Health at external marketing and promotional events

2.2 Clinical Skills

Possesses specialist, current, clinical knowledge and skills in a relevant health profession and applies this to lead and develop individuals and teams in clinical practice.

Indicators:

- Demonstrates clinical expertise through knowledge of research, new developments and evidence-based practice
- Acts as a role model for staff in promoting professional values and ethics in clinical practice
- Fosters excellence by promoting a best-practice philosophy and patient/client-centered care
- Understands Eastern Health policies and legislative requirements which impact on wider clinical issues and practices
- Maintains required and appropriate documentation including reporting to Learning and Teaching and Profession as required.

2.3 Communication

Possesses strong communication skills with demonstrated ability to negotiate, collaborate and consult widely with internal and external stakeholders.

Indicators:

- Demonstrates advanced verbal and written communication skills in all professional domains of practice, including conference presentations, publications and research/project proposals
- Demonstrates the capacity to liaise with internal and external peers, stakeholders and clients.
- Demonstrates proven ability to negotiate conflict resolution.

2.4 Organisational Skills

Provides leadership and innovation in organisational and time management skills.

Indicators:

- Ability to organise programs and special projects as well as the ability to delegate to individuals where appropriate
- Manages and provides assistance to learners and supervisors in supporting a great clinical environment through timely, responsive and value based communication and patient care.

2.5 Organisational Knowledge / Development

Possesses a clear understanding of the factors affecting healthcare, and applies this knowledge to lead activities and projects which deliver improved services and health outcomes at a campus and health service level with a focus on the novice learner experience. Indicators:

- Plans, initiates, coordinates and contributes to quality improvement activities, and showcases the work at forums/conferences within and external to Eastern Health
- Demonstrates strong corporate/ organisational knowledge and has established, or has the capacity to establish, a strong professional network with the key stakeholders
- Demonstrates capacity to facilitate the strategic initiatives of the Learning and Teaching Directorate
- Actively contributes to preparation for and achievement of Accreditation Standards
- Applies and communicates to all stakeholders the Eastern Health Policies, Standards and Guidelines
- Demonstrates experience and awareness of financial policies and budgets

2.6 Professional Development and Supervision

Demonstrates a capacity to apply and integrate knowledge from professional development into the development and implementation of practice and program initiatives.

Indicators:

- Integrates Learning and Teaching Directorate Plan into relevant internal and external professional development activities
- Acts as a role model in demonstrating a strong commitment to professional development
- Leads and continues to develop a supportive learning environment for all learners at Eastern Health
- Utilises an evaluation framework to support the continued improvement of Learning and Teaching at Eastern Health
- Undertakes a formal supervision process with Professional line
- Liaises and seeks supervision from line manager with respect to own performance management / expectations.

2.7 Teaching and Research

Initiates, leads and supports other staff in teaching, training and research programs.

Indicators:

- Plans, initiates, coordinates and participates in research within Eastern Health and in collaboration with other partners
- Promotes an organisational commitment to research and quality improvement activities
- Demonstrates leadership with all learner programs
- Promotes research via publication or presentation at forums and external conferences and supports professional development of staff in this area

3. SAFE PRACTICE AND ENVIRONMENT

Occupational Health and Safety

Eastern Health is committed to provide and maintain a working environment for all staff that is safe and without risk to health. All staff are to take care of their own health and safety and the health and safety of any other person who may be affected by your acts or omissions at the workplace. 4. TRAINING AND DEVELOPMENT

All programs should endeavour to promote evidence-based practice, a problem solving approach and to be competency based.

You are expected to participate in the personal development process on an annual basis.

5. QUALITY

As a staff member of Eastern Health staff are required to comply with Eastern Health performance standards and participate in continuous monitoring and improvement as part of your role. You are also required to comply with legislation, professional standards and accreditation standards.

As a staff member employed by Eastern Health services you must have and maintain the appropriate skills and knowledge required to fulfil your role and responsibilities within the organisation. In addition, you must ensure that you practice within the specifications of this position description, and where applicable within the agreed scope of practice.

You are responsible for ensuring safe high quality care in your work. This will include complying with best practice standards, identifying and reporting any variance to expected standards and minimising the risk of adverse outcomes and patient harm. In addition, you will ensure that service and care is consistent with the EH approach to patient and family centered care.

6. CONFIDENTIALITY

Any information obtained in the course of employment is confidential and should not be used for any purpose other than the performance of the duties for which the person was employed. Staff are bound by the Information Privacy Act 2000 and the Health Records Act 2001.

7. EQUAL EMPLOYMENT OPPORTUNITY

You agree to adhere to the Equal Employment Opportunity policies and practices of the Health Service. Discriminatory practices, including sexual harassment, are unlawful. The Health Service will not tolerate discriminatory behaviour and any such conduct may lead to the invoking of the Disciplinary Policy and Procedure, which may result in termination of employment.

8. PERFORMANCE DEVELOPMENT

A Performance Review, that includes agreed targets, will occur three (3) months from commencement and then annually on the basis of the duties and responsibilities outlined in this position description. This is an opportunity to review personal and the allocated work unit's service performance, facilitated by the setting of objectives/goals and ongoing evaluation of performance and achievement. Objectives will be developed annually, documented, discussed and agreed with the immediate line manager, who will act as the assessor. The incumbent is expected to demonstrate and show evidence annually of on-going self and allocated work unit's service development.
